

**Terms & Conditions** 

Wetskills-Egypt 2023

## The participant declares by registration that:

- He/she is able to attend the Wetskills Water Challenge programme in Egypt during the period of 21 October to 1 November 2023. (Note: the dates could change)
- He/she is able to pay the programme fee of maximum:
  - \*€ 395.- (excl. VAT) for international and local participants needing accommodation during the programme
  - $\mathbf{\in}$  25.- (VAT free) for local students who already have accommodation

The programme fee includes: field trips, workshops, working locations, supervision, some meals and the Finals and Awarding ceremony.

• He/she is responsible for his/her own travel expenses (plain tickets, train, bus, etc.) and all other costs not included in the program fee.

N.B. The Wetskills organisation is striving to find possibilities to keep the costs to the participants at a minimum. During past editions participants often successfully arranged financial compensation for their Wetskills participation from their university or employer. We therefore strongly encourage applicants to inquire about funding opportunities to compensate the costs (mobility funds, travel allowance etc.).

- Cancelation procedures
  - Till the final registration deadline of this Wetskills event and 3 days after the Acceptation email, he/she can refuse the participation by sending the organisation e-mail.
  - A cancellation after 3 days of receiving the acceptation email, but two months before the start of the Wetskills programme, he/she will pay 25% of the participation fee to the organisation.
  - A cancellation between one and two months before the start of the Wetskills programme, he/she will pay 50% of the participation fee to the organisation.
  - A cancellation within a month before the start of the Wetskills programme, he/she will pay 100% of the participation fee to the organisation.
  - In case the travel regulations between the involved countries change due to corona (COVID-19) virus during the Acceptance email and the Start of the programme, the participants will get back the participation fee. Wetskills Foundation and partners <u>will not</u> be responsible for compensation for costs as travel tickets, quarantine time or repatriation flights.
- He/she bears full responsibility for own behaviour and the risks of the program. He/she acknowledges that the organisation and its partners are not responsible for any damage to personal belongings during participation in the program.
- He/She bears full responsibility of dealing with the corona (COVID-19) virus according to the
  regulations and direction of the WHO, Dutch and local government and the country where he/she is
  living. <u>Wetskills Foundation and partners will not be responsible for compensation for costs as travel
  tickets, quarantine time or repatriation flights. Only participation fees will be recovered.

- Before, during and after the Wetskills programme, Wetskills Foundation will treat the personal data according to the AGV regulations in The Netherlands, which is based on the General Data Protection Regulation (GDPR) of the EU.
