

Terms & Conditions

Wetskills-South Africa 2024 (Durban)

The participant, upon registration, affirms that:

- They commit to attending the Wetskills Water Challenge program in Durban, South Africa, scheduled from 2 to June 14, 2024.
- They acknowledge the program fee, which is a maximum of €3958 (excluding VAT, with VAT applicable only for participants from The Netherlands). This fee applies to international and local participants requiring accommodation in Durban during the program.

The programme fee includes accommodation (hostel, sharing rooms with more participants), field trips, workshops, working locations, supervision, some of the meals, and the Finals and awards. Wetskills Foundation and partners strive to lower the costs for local participants.

*NOTE: This does NOT Include WISA entrance, which is estimated to be €250

- They acknowledge personal responsibility for covering travel expenses (including plane tickets, train fare, bus transportation, etc.) and any additional costs not encompassed by the program fee.

 N.B. The Wetskills organisation strives to find possibilities to keep the costs to the participants at a minimum. During past editions, participants often successfully arranged financial compensation for their Wetskills participation from their university or employer. We therefore strongly encourage applicants to inquire about funding opportunities to compensate for the costs (mobility funds, travel allowance, etc.).
- Cancellation procedure
 - Till the final registration deadline of this Wetskills event and **three days** after the Acceptation email, they can refuse participation by sending the organisation email.
 - A cancellation after **three days** of receiving the acceptance email but two months before the start of the Wetskills programme they will pay 25% of the participation fee to the organisation.
 - Cancellation between one and two months before the start of the Wetskills programme, they will pay 50% of the participation fee to the organisation.
 - A cancellation within a month before the start of the Wetskills programme will result in payment of 100% of the participation fee to the organisation.
 - In case the travel regulations between countries change due to the coronavirus (COVID-19) between the acceptance email and the programme's start, the participants will get back the participation fee. Wetskills Foundation and its partners will not be responsible for compensation for costs such as travel tickets, quarantine time, or repatriation flights.
- They bear full responsibility for their behaviour and the risks of the program. They acknowledge that the organisation and its partners are not responsible for any damage to personal belongings during participation in the program.
- They bear full responsibility for dealing with the coronavirus (COVID-19) according to the regulations
 and direction of the WHO, South African and Dutch governments, and the country where they live.
 Wetskills Foundation and its partners will not be responsible for compensation for costs such as travel
 tickets, quarantine time, or repatriation flights. Only participation fees will be recovered (see also
 cancellation procedures).
